- Finance Committee Report—Rishi Nixon. Rishi was absent, Items were reported later in agenda.
- 2024 NSN Conference Update—Margaret Read MacDonald and Delanna Reed--Committee has suggested we offer a discount to those whose proposals were not accepted to attend the conference. Committee withdrew this request.

57 programs were accepted for 2024 NSN Conference. 69 participants in these programs.

Panels will receive 4 paid early bird registrations. 2 was considered a more reasonable number, but the proposal announcement did not make that clear.

The Conference Committee requests that \$1000 be added to the conference budget to cover a caller and band to follow the Oracle Award Ceremony.

Registration opens January 20 and Early Bird closes May 15, 2024.

- Angela Lloyd (YES) YES is planning Story Labs for YES members, \$15 for non-members. The YES monthly coffee hour continues. They are considering a pre-conference day in spring. YES is reaching out to youth tellers to join their board. Note that Storytelling in Higher Education folded into YES a few years ago.

Angela suggests a meeting of NSN in January.

Oracle Awards Report by Angela: The day clocks are set back,proposals begin being accepted. This closes the day the clocks go back in March. Sara Juba Addison is chair of the Oracle Awards Committee.

Unfinished Business

 Conference Attendance Stipends—recommendation from Conference and Finance Committee (Also, should we consider a special "hardship" discount for those desiring to attend conference but have limited means?). Presented by Linda Marchisio.

The Finance Committee recommends a Katherine Tucker Wyndham Scholarship to be given to five individuals. Katherine gave the first \$5 to start fundraising, so this is in her honor. The award would cover registration and meals. And for non-members would also include free membership in NSN for one year. It is open to anyone to apply. Those receiving the award would be asked to write a reflection on their time at the conference, which might be published in the NSN newsletter. They would also be expected to volunteer at the conference. The cost of this is estimated to be \$2,535.

Motion: That NSN use monies from the 2023 Auction proceeds to fund the Kathryn Tucker Wyndham Scholarship Fund for the 2024 Annual NSN Conference. Moved by Trudy Hanson. Passed unanimously.
