Ad Hoc Committee on Strategic Planning

The committee recommends the following Bylaws change:

Motion: To amend the bylaws by adding: The Strategic Planning Committee will be composed of at least: one executive board member, two board members (including a SIG representative), two NSN members, and one external expert (This will be added under Article 9.2, (m). Moved by Trudy Hanson. Passed unanimously.

Additionally, the Ad Hoc Committee has asked for a review of the current NSN Board Application form and the information requested, as well as the difference in the process for becoming a board member (Board Applicants who apply directly and those elected by SIGS). Not discussed.

- Updated and Revised Tellabration Guidelines--Trudy and Dot (We also recommend that the PRO SIG develop a brief video that discusses choosing a venue, getting the word out, and managing the event.) Discussion of Tellabration document. Might include photo of J.G. Pinkerton.

Motion: That the revision be accepted. Tabled until May meeting to allow board chance to examine the document further.

Fractional Executive Proposal--Rishi Nixon

- 1. To name Dot Cleveland as NSN's Chief Operating Officer on a fractional basis with flexible part-time hours,
- 2. To set her base compensation *this year* at \$10,000 (already budgeted, this would just make sure she hits the full amount),
- 3. And to award Dot an end-of-year bonus of one-tenth NSN's net income (profit) in FY24, if that is a positive number.

Dot feels a more pressing need is for NSN to hire a Marketing Director. No money in budget for this yet, we need to fill board position for marketing.

Title will be changed from Bookkeeper.

Rishi withdrew his motion.

 New Services available to NSN Members (Canva and NSN Store in operation) --Dot Cleveland

Store in operation again after being down for some time. Many expired items removed.

Canva Pro is offered to non-profits for free. SIGS can be on our CANVA as part of NSN team.

Lisa Williams suggested that National Storytelling Network create an agreement form that gives National Storytelling Network permission to upload and sell events (ie. Presentations, panel discussions, workshops) of the presenter (s) on the NSN website page.

Lisa Williams suggested that prior events should not be uploaded and sold on NSN store website page, because attendees of prior events were not made aware of its distribution/selling on the NSN store website page. [Note that in cases such as Fringe performances and others, the presenters knew that their work would be sold on the NSN webpage.]

Workshops can be made just to those who registered for an event...not put in store.

Put on ads for future programs/workshops "This is going to be recorded for those who purchase a ticket."
